Request for License Fee Exemption

Exemption for entrepreneurs from special fees related to the project and reduced fee for license renewal.



Requirements

- Copy of National ID card
- Copy of passport or original decree (for non-abstract holders), addressed to the DET

- AED 1,000 administrative fee every year, for the first three years
- AED 2,000 administrative fee every year for the 4th and 5th years

N.B. Exemption applies only to issuance/ renewal of licenses from the Department of Economy and Tourism and other local authorities only. Not applicable to fees of federal government or private entities.

Request for Intelag License

Intelag is a license issued to UAE or GCC national(s) residing in Dubai, to run a business from home, for a minimal annual fee.



Requirements

- Location of the house/ residence should be in the Emirate of Dubai
- The enterprise shall be 100% owned and managed by UAE or GCC national(s)
- The applicant shall not have more than five trade licenses (including licenses that he/she fully or partially owns or manages)

- GCC Nationals (UAE residents)



Request for Project Incubation

Services include:



Request for Certifying Business Incubators and Accelerators

Certifying business incubators and accelerators in Dubai is intended to provide an opportunity to expand investments in varied entrepreneurial platforms, such as, business incubators, accelerators and co-working spaces. The service seeks to ensure necessary guidance and follow-up to small and medium enterprises, organise the work of business incubators and accelerators in Dubai, as well as provide the ideal environment for owners of emerging and creative projects to conduct business.



Requirements

- Integrated feasibility study for the business incubator, including the type of incubator, objectives, services provided, packages, work team, partners, etc.
- Incubator operating plan
- Copy of the applicant's passport, trade license or decree establishing the entity
- Location sketch showing a rented area of at least 1,500 square-foot
- Notarised and certified lease contract for space rented (for issuing lease contracts and trade licenses for companies registered in the incubator. Applicable even if the signatories are affiliated with the same entity seeking to establish the incubator).

Funding Services

Provided by Mohammed Bin Rashid Fund for SMEs

Request for Consultation on Funding

The service includes financial evaluation, cash flow, business plan, and the financial performance of the implemented or planned projects. The strengths and opportunities for improvement are analysed, along with the mechanism for its optimal implementation.

Request for Seed Capital Loan

Interest-free financing of up to one million dirhams, for a period not exceeding five years (not including the grace period of up to 24 months). Payments are made monthly through soft and fixed premiums. The service is a financing solution for new companies, to cover the costs of establishing the project.

Request for Credit Loan

Entrepreneurs can obtain high-value credit loans of 1-3 million dirhams through bank guarantee from one of Dubai SME's banks and financial institution partners. Low interests, in addition to a grace period for repayment, to enable Dubai SME members to cover costs and generate profits.

Request for Loan on Invoices and Local Purchase Orders (LPO)

Interest-free financing on invoices and purchase orders, aimed to help businesses maintain liquidity. Financing covers value of the invoice or purchase order until the receipt of the goods or service, with an interest-free installment payment option.

Request for Granting Collateral for Crowdfunding

The service of providing loans to small and mediumsized enterprises through the Fund's credit guarantee to national enterprises in partnership with the "Beehive" platform, where the partner offers a new and innovative method of financing through the crowdfunding mechanism, and the loan is made available no later than one month from the date of submission, allowing the applicant to make payments in monthly soft payments of up to three years.





Funding Services (cont.)

Provided by Mohammed Bin Rashid Fund for SMEs

Request for Expansion Loan

It is a loan designed to encourage and motivate entrepreneurs to grow/expand in companies/sectors (related to F&B activity only) which they see potential for growth and satisfactory returns in the long term.

Request for Term Finance Loan

It is a loan offered to entrepreneurs who are facing difficulties in meeting the payments of their expenses when they are due. It is an interest-free product in which the Mohammed Bin Rashid Fund covers the company's expenses and is reimbursed by the entrepreneur in the form of monthly payments.

Request for Asset Funding Loan

Asset Funding Loan provided by Dubai SME is an interest-free product in which the Mohammed Bin Rashid Fund covers a maximum of 80% of the value of assets and is reimbursed by the entrepreneur in monthly installments.




